Official Rules for the Intel[®] Inspiring Educators Contest

These rules (the Rules) govern the Intel[®] Inspiring Educators contest (the "contest") and set out the terms and conditions between Intel Corporation and its affiliates ("Intel" or "us/we") and each participant ("participant" or "you"). A submission to this contest constitutes your acceptance of these Rules.

- 1. **How to Enter**: Intel Corporation, (the "Sponsor") is offering Intel[®] Inspiring Educators contest (the "Contest") and will award prizes based on the results of judging all valid entries against the criteria established in these Official Contest Rules (the "Rules"). Submit an on-line entry in the designated area of the Intel Teach Educator Community <u>www.engage.intel.com</u> between 8 a.m. PDT Sunday, Nov. 1 and 5 p.m. PST Wednesday, Feb. 17 ("contest period"). During the contest period submit your entry by completing the entry form in the Intel Teach Educator Community and linking to your presentation or video that is housed on a free, easily accessible website such as Utube, Prezi, Teacher Share or Slide Share.
- 2. **Eligibility**: Contest is open to all certified Master Teachers and Senior Trainers, participating LEAs, and Participant Teachers in the United States Intel Teach Program. Contestants must have participated in the Intel Teach program. Employees, officers and representatives (and members of their immediate families and those living in the same household of each) of Intel Corporation, its parents, subsidiaries and affiliated companies, advertising and promotion agencies and any company involved in the design, execution, production or judging of this promotion ("contest entities") are ineligible. Void where prohibited.
- 3. **Entry Requirements**: All entries must show how the Intel Teach program has influenced students' learning, how an MT or PT training has changed classroom learning or how the training has changed the way a teacher teaches. Entry options are: an essay not to exceed 1,000 words, a 10-slide presentation, or a 2-minute video. If the entry is in a format the judges are unable to view, judges may request an alternate format be submitted. Release agreements must be submitted with the entry for all people in all photographs and/or videos submitted.
- 4. **Judging**: Submissions will be judged between Feb. 18 and March 8 by members of the Intel Teach Program Team. Judges with evaluate all eligible submissions on the following criteria: impact on student learning, change in teaching practice or effective integration of technology into the curriculum. Judges' decisions are final. You may withdraw your submission at any time by notifying Sponsor. If a submission is withdrawn your right to win a prize is terminated.
- 5. **Ownership and Publicity**: Sponsor does not claim ownership of your submission to the contest; but by submitting an entry, you are granting Sponsor and its affiliated companies the following worldwide, non-exclusive, perpetual, irrevocable, royalty-free, unconditional, fully paid-up rights: (1) to make, have made, use, copy, reproduce, modify, and create derivative works of the contributions, (2) to publicly perform or display, import, broadcast, transmit, distribute (directly and indirectly through multiple tiers), license, offer to sell and sell, rent, lease, or lend copies of the contributions (and derivative works thereof), (3) to sublicense to third parties the foregoing rights, including the right to sublicense to further third parties, and (4) to publish your name or alias in connection with this contest and your contributions. Winners will be required to send Sponsor a copy of their presentation or video.

Contestants understand and agree that their submission may be posted and publicly viewable. By providing a submission, you grant Sponsor and its affiliated companies the right, except where prohibited by law, to use your name for promotional purposes in promoting or publicizing the contest. Sponsor, however, does not have any obligation to use the winning Entries for any purpose.

- 6. **Participant Warrants**: By submitting an entry you warrant that your submission:
 - does not contain any content that infringes on any third party intellectual Property (IP) rights, and that you own or otherwise have all rights necessary for the submission including any and all IP rights
 - does not disclose any information which would constitute a violation of a confidentiality obligation;
 - does not contain any viruses, worms, spy ware, or other components or instructions that are malicious, deceptive, or designed to limit or harm the functionality of a computer; and
 - is not subject to license terms that require any software or documentation incorporating or being derived from your contributions to be licensed to others.
- Prizes: 20 prizes will be awarded based on the judging. Prizes will consist of a round-7. trip, non-refundable, economy class air transportation for Winner between the major airport nearest the Winner's U.S. residence and the Denver, CO area; single room hotel accommodations in Denver, CO for Winner for three (3) consecutive nights; one ISTE 2010 (Formerly the National Educational Computing Conference [NECC]) registration, which will take place June 27-30, 2010 at the Colorado Convention Center in Denver, CO; and \$250 stipend for food and miscellaneous expenses. The Approximate Retail Value ("ARV") of each Winner prize is \$1500.00 (actual value depends on airport city of departure). The airline tickets and hotel accommodations may only be used in connection with travel to Denver, CO to attend ISTE 2010. Total of all Prize packages is ARV \$30,000. Limit of one prize per submission. Winners will be notified via email within] seven (7) days from judging.
