In accordance with Your Honor's entry earlier today of the Order Modifying the Time for filing of objections to Special Master Poppiti's December 2, 2008 Report and Recommendation regarding jurisdiction over the Dell witness deposition dispute, Dell has just filed Objections to the Report and Recommendation (D.I. 1146 in C.A.
