### DECLARATION OF (TOSHIBA CORPORATION)

I, submit this declaration in connection with the above-referenced litigation.

1. I am the ' of Toshiba Corporation ("Toshiba"). I have been working at Toshiba for the past years and am familiar with Toshiba's structure and business operations. I am over the age of twenty-one and give this declaration on the basis of my personal knowledge, investigation and belief for use in the abovereferenced litigation.

2. Toshiba is a Japanese corporation, organized under the laws of Japan, with its principal place of business in Tokyo, Japan. Toshiba manufactures and sells a wide range of products (from semiconductors to power plants) and services into a variety of markets, including automotive products, network services, digital media products (HDDs, DVDs, TVs, etc), mobile phones, personal computers, power systems, semiconductors, social infrastructure (building energy management systems, power supply systems, highway traffic control systems, radar systems, power distribution systems, railway station service systems, etc.), transmission distribution and industrial systems (switchgears, power transformers, industrial computers, instrumentation, etc.), among others.

3. Personal Computer and Network Company ("PC&NC"), a unit of Toshiba based in Tokyo, Japan, is responsible for all or substantially all Toshiba personal computers ("PCs") businesses. PC&NC oversees the manufacturing and sourcing of Toshiba PCs from China and elsewhere in Asia. PC&NC does not manufacture Toshiba PCs in the United States.

4. PC&NC has been responsible for all or substantially all purchases of CPUs, including CPU purchases from Intel and AMD. PC&NC has procured all or substantially all Intel CPUs from Intel Kabushiki Kaisha in Japan, and has procured all or substantially all AMD CPUs from AMD Japan Ltd. in Japan.

5. All or substantially all Toshiba PCs manufactured or sourced by PC&NC are sold by PC&NC to regional subsidiary companies owned directly or indirectly, wholly or in part, by Toshiba that operate around the world.

6. Toshiba does not do business in Delaware or the United States and has not had a business presence in Delaware or the United States to the best of my knowledge at any time. For example:

- a. Toshiba is not listed on any U.S. stock exchange.
- b. Toshiba is not registered with any Secretary of State to do business in any U.S. state.
- c. Toshiba is not licensed to sell products in Delaware or the United States.
- d. Toshiba has no registered agents, and has not authorized or appointed any entity to act as its general agent, in Delaware or the United States.
- e. Toshiba does not maintain any offices in Delaware or the United States.
- f. Toshiba does not own any real estate in Delaware or the United States.
- g. Toshiba does not maintain any telephone listings or mailing addresses in Delaware or the United States.

- h. Toshiba does not maintain bank accounts in Delaware or the United States.
- i. Toshiba has not filed or been obligated to file tax returns, or to pay taxes, in Delaware or the United States.

7. Toshiba has approximately 550 subsidiaries worldwide. Toshiba follows a corporate structure whereby wholly and partially owned subsidiary companies operate independently in the regions that they serve.

8. Toshiba America, Inc. ("TAI"), headquartered in New York City, is a holding company that wholly owns or owns the majority of the voting rights of certain operating corporations that serve the United States (collectively the "TAI subsidiary corporations").

9. TAI and the TAI subsidiary corporations maintain separate corporate identities from each other and from Toshiba. Toshiba does not direct or control the day-to-day management or operations of TAI or the TAI subsidiary corporations. TAI and the TAI subsidiary corporations each have their own separate and independent Boards or Directors which bear responsibility for the governance of each respective corporation. TAI and the TAI subsidiary corporations are each directed by their own separate management employees, not by Toshiba.

10. One of the TAI subsidiary corporations is Toshiba America Information Systems, Inc. ("TAIS"), a California corporation based in Irvine, California. TAIS sells all or substantially all Toshiba PCs in the United States. Toshiba does not direct or control TAIS's day-to-day management or operations, including its sales or marketing efforts.

11. TAI and the TAI subsidiary corporations conduct business separately from Toshiba. For example:

- a. All corporate formalities between and among the companies are maintained and observed.
- b. The companies conduct separate board meetings and maintain separate minutes of such meetings.
- c. The companies have separate day-to-day management.
- d. The companies are responsible for their own hiring and firing.
- e. The companies maintain their accounts as independent companies, including separate financial and accounting systems.
- f. The companies maintain separate corporate records, including, among other things, separate sales, personnel, and tax records.
- g. The companies do not commingle operating funds.

- h. The companies have their own headquarters and office space.
- i. The companies select their own advertising and marketing.
- j. The companies purchase products upon their own initiative and based upon need within their own operations.
- k. It is up to TAIS to sell or dispose of the PCs it purchases from PC&NC as it sees fit.

12. Toshiba is not responsible for paying the Delaware or United States taxes of TAI, TAIS or any of the other TAI operating corporations. Nor are TAI, TAIS or any of the other TAI operating corporations responsible for paying taxes owed by Toshiba in Japan.

13. I have reviewed the document subpoena purportedly served by AMD on Toshiba "c/o" TAI and TAIS. Neither TAI nor TAIS has the authority to demand or procure such Toshiba documents from Toshiba, nor are such Toshiba documents within TAI's or TAIS's possession, custody or control. Neither TAI nor TAIS has access to such Toshiba documents in the ordinary course of business, and neither TAI nor TAIS would be able to produce them for inspection. A request to Toshiba by TAI or TAIS for such Toshiba documents would be refused.

I declare under penalty of perjury under the laws of the United States of America that the foregoing is true and correct.

I give this declaration on the basis of my personal knowledge, investigation and belief for use in the above-referenced litigation. 2. TAIS is a California corporation based in Irvine, California. TAIS is an independent subsidiary operating corporation of Toshiba America, Inc. ("TAI").

3. TAIS is an independent subsidiary operating corporation of TAI, and is identified as such in press releases and other information disseminated to the public. For example: Press Release, "Toshiba Adds Half-Terabyte Portable External HDD to Personal Storage Line" http://www.toshibastorage.com/techdocs/PR2009-01b-500GBExternalHDD.pdf (Exhibit A at 3) ("TAIS provides sales, marketing and services for its wide range of information products in the United States and Latin America. TAIS is an independent operating company owned by Toshiba America, Inc., a subsidiary of Toshiba Corporation...."); Companies & Businesses, www.toshiba.com/tai/about\_ us/about\_oc.jsp (Exhibit B at 1) (describing TAIS and its four business units).

4. TAIS provides sales, marketing, and services for various products, including personal computers ("PCs"). TAIS sells all or virtually all Toshiba PCs in the United States. TAIS purchases Toshiba PCs in Japan from Personal Computer & Network Company ("PC&NC"), a Toshiba subsidiary corporation based in Tokyo, Japan. TAIS does not own or have any interests in any subsidiaries.

5. TAIS maintains a separate and independent corporate identity from Toshiba Corporation ("Toshiba"). TAIS maintains and observes all corporate formalities as a separate corporation from Toshiba. TAIS's business operations in the United States are independent of, and separate from, Toshiba. For example:

- a. TAIS has a separate and independent Board of Directors and management from Toshiba. None of these individuals is an employee of Toshiba. TAIS's Board of Directors bears overall responsibility for management and governance of TAIS;
- b. TAIS conducts board meetings separately and independently from Toshiba, and maintains separate minutes of such meetings;
- c. The day-to-day business management and operations of TAIS are directed by TAIS's own management employees. TAIS's day-to-day management is separate and independent from Toshiba. No employees work on the day-to-day business matters of both Toshiba and TAIS;
- d. TAIS is responsible for its own hiring and firing;
- e. TAIS maintains its accounts as an independent company, including separate accounting and financial systems;
- f. TAIS maintains separate corporate records, including, among other things, separate sales, personnel, and tax records;
