

expert witness reports and for scheduling of expert witness depositions in the AMD Action;

WHEREAS, the parties agree that additional time will be required to permit the parties to adequately prepare their expert witness reports and for expert witness depositions;

WHEREAS, the parties further agree that, subject to the approval of the Court, all other case deadlines, including the trial date, should not be extended;

WHEREAS, scheduling of depositions of certain third-party witnesses affiliated with HP could not be accomplished during the June 12, 2009 fact discovery deadline set forth in Case Management Order No. 7;

NOW, THEREFORE, IT IS HEREBY STIPULATED BY AND AMONG AMD, CLASS PLAINTIFFS, AND INTEL, THROUGH THEIR RESPECTIVE COUNSEL, AND SUBJECT TO THE APPROVAL OF THE COURT, AS FOLLOWS:

1. The deadlines set forth in Case Management Order No. 7 shall be extended as follows:
 - a. AMD will serve its expert witness reports in the AMD Action on Monday, August 3, 2009.
 - b. Intel will serve its expert witness reports in the AMD Action on Monday, October 5, 2009.
 - c. AMD will serve any rebuttal expert witness reports in the AMD Action on Monday, November 2, 2009.
 - d. Expert witness depositions in the AMD Action shall occur between Tuesday, November 3, 2009 and Monday, December 7, 2009. This stipulation shall not

alter the parties' agreement to cooperate in the scheduling of expert witness depositions such that expert witnesses expected to submit declarations relating to summary judgment motions are deposed as early as possible in the expert deposition period.

2. With the exception of certain matters left open by stipulation or by contested discovery disputes and with the exception of the depositions of certain third-party witnesses affiliated with HP, fact discovery in the above-captioned actions has concluded. The depositions of the final third-party witness affiliated with HP shall conclude by Wednesday, July 29, 2009.

3. All other case deadlines, including the trial date, shall remain as set forth in Case Management Order No. 7.


