ORDER

WHEREAS, simultaneously herewith the Special Master has issued an Report
and Recommendation DM 36 on defendants Intel Corporation and Intel Kabushiki

Kaisha's ("Intel") Motion to Compel documents and testimony from Glover Park Group ("Glover Park"), a consultant for Plaintiffs, Advanced Micro Devices, Inc. and AMD International Sales & Service, Ltd.

WHEREAS, the Special Master concludes that it is critically important to achieve final decision in this matter on an expedited basis;

WHEREAS, the Special Master believes that the time within which a party may, pursuant to Fed. R. Civ. P. 53(f)(2), file objections to – motion to adopt or modify – any Special Master's Report and Recommendation should be shortened;


WHEREAS, consistent with this approach the Special Master believes that any briefing to the Court on a Fed. R. Civ. P. 53(f)(2) application should be expedited, with a shortened page limit;

NOW THEREFORE, IT IS HEREBY RECOMMENDED THAT THE COURT:

1. Reduce the time permitted by Fed. R. Civ. P. 53(f)(2) from no later than 20 days from the date of the Report and Recommendation, to no later than 5 days from the date of the Report and Recommendation.
2. The initial brief in support of Fed. R. Civ. P. 53(f)(2) application should not exceed 5 pages single-spaced. Opposition letter briefs shall be served not later than 4 days following service of the application and shall not exceed 5 pages, single-spaced.

Reply letter briefs shall be served not later than 3 days following service of the opposition brief and shall not exceed 3 pages single-spaced.
