STIPULATION AND ORDER AMENDING THE COURT'S ORDER REGARDING THE ISSUANCE OF THE FRENCH LETTER ROGATORY (D.I. 1746)

WHEREAS, by correspondence dated February 9, 2009, Advanced Micro Devices, Inc. and AMD International Sales & Services, LTD (jointly, "AMD") requested that the Special Master recommend the issuance of Letters Rogatory to the appropriate judicial authorities in

France and Italy, respectively, requesting the production of certain documents in the possession of European corporations, NEC Computers SAS and ACER Italy Srl (D.I. 1225 and 1226);

WHEREAS, by correspondence dated March 30, 2009, the Special Master requested that the European Commission ("EC") inform the Court of its position on the discoverability of such documents;

WHEREAS, on April 23, 2009, the Special Master entered an order recommending that the Court issue the Letters Rogatory (D.I. 1730);

WHEREAS, on April 27, 2009, the Court entered orders issuing the Letter Rogatory to the appropriate judicial authority in Italy (D.I. 1745) and the appropriate judicial authority in France (D.I. 1746);

WHEREAS, the order issuing the Letter Rogatory to the French judicial authority (D.I. 1746) provides, in part, that the French authority "direct NEC SAS to produce the requested documents to the Special Master, who will hold them pending receipt of the European Commission's response and issuance of a final ruling on whether AMD should be permitted to inspect and copy the requested documents";

WHEREAS, on July 27, 2009, the Special Master received the European Commission's response to the March 30, 2009 request (D.I. 2036);

WHEREAS, by letter dated July 31, 2009, the Special Master requested that the parties inform the Court of their respective positions on the European Commission's response (D.I. 2037); and

WHEREAS, subsequent to the Special Master's July 31, 2009 letter, AMD and Intel Corporation and Intel Kabushiki Kaisha (jointly, "Intel") agreed that AMD should receive the requested documents directly from NEC SAS if the appropriate French court orders them

produced;

NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED, subject to the approval of the Court, that the Court's April 27, 2009 order issuing the Letter Rogatory to the appropriate French judicial authority (D.I. 1746) shall be amended to provide that upon receiving documents from the French court, the Special Master shall provide them to counsel for AMD and Intel.
