
**ORDER GRANTING UNOPPOSED MOTIONS OF NON-PARTY  
HEWLETT-PACKARD COMPANY FOR EXTENSIONS OF TIME  
TO MOVE TO LIMIT OR QUASH SUBPOENAS *DUCES TECUM***

On April 16, 2010, non-party Hewlett-Packard Company (“HP”) submitted two unopposed motions for extension of time: (1) a Fourth Unopposed Motion for Extension of Time for HP to move to limit or quash a Subpoena *Duces Tecum* served on it by Complaint Counsel on March 8, 2010; and (2) a Third Unopposed Motion for Extension of Time for HP to move to limit or quash a Subpoena *Duces Tecum* served on it by Respondent Intel on March 19, 2010 (collectively, “HP’s Unopposed Motions for Extension of Time”).<sup>1</sup>

HP states that Complaint Counsel has agreed to a fourth extension of time for HP to move to limit or quash Complaint Counsel’s subpoena, until April 29, 2010, while the parties try to reach agreement on the scope of the subpoena. Regarding the subpoena from Intel, HP states that Intel does not oppose a third extension of time for HP to file a motion to limit or quash Intel’s subpoena, until May 3, 2010, so that the parties can try to reach agreement on the scope of that subpoena.

Based on the foregoing, HP’s Unopposed Motions for Extension of Time are each GRANTED, and it is hereby ORDERED that: (1) HP shall have until April 29, 2010 to file a motion to quash or limit the subpoena served upon HP by Complaint Counsel on March 8, 2010; and, (2) HP shall have until May 3, 2010 to file a motion to quash or limit the subpoena served upon HP by Intel on March 19, 2010.
