Main Memory



To be fully compliant with all applicable Intel[®] SDRAM memory specifications, the board should be populated with DIMMs that support the Serial Presence Detect (SPD) data structure. If your memory modules do not support SPD, you will see a notification to this effect on the screen at power up. The BIOS will attempt to configure the memory controller for normal operation.

Hi-Speed USB 2.0 Support

Computer systems that have an unshielded cable attached to a USB port might not meet FCC Class B requirements, even if no device or a low-speed USB device is attached to the cable. Use a shielded cable that meets the requirements for a full-speed USB device.

The desktop board supports up to eight USB 2.0 ports via ICH7 or ICH7R; four ports routed to the back panel and four routed to two internal USB 2.0 headers. USB 2.0 ports are backward compatible with USB 1.1 devices. USB 1.1 devices will function normally at USB 1.1 speeds.

USB 2.0 support requires both an operating system and drivers that fully support USB 2.0 transfer rates. Disabling Hi-Speed USB in the BIOS reverts all USB 2.0 ports to USB 1.1 operation. This may be required to accommodate operating systems that do not support USB 2.0.

Enhanced IDE Interface

The ICH7's IDE interface handles the exchange of information between the processor and peripheral devices like hard disks, CD-ROM drives, and Iomega Zip* drives inside the computer. The interface supports:

- Up to two IDE devices (such as hard drives)
- ATAPI-style devices (such as CD-ROM drives)
- Older PIO Mode devices
- Ultra DMA-33 and ATA-66/100 protocols
- Laser Servo (LS-120) drives

Serial ATA

The desktop board supports four Serial ATA channels (3.0 Gb/s) via ICH7 or ICH7R, connecting one device per channel. Desktop boards with ICH7R support Intel Matrix Storage Technology (NCQ, Hot Plug, RAID 0, 1, 10, 5, and Matrix RAID).

Expandability

The desktop board supports the following:

- One PCI Express x16 add-in card
- One PCI Express x1 add-in card
- Two PCI add-in cards

BIOS

The BIOS provides the Power-On Self-Test (POST), the BIOS Setup program, the PCI/PCI Express and IDE auto-configuration utilities, and the video BIOS. The BIOS is stored in the Firmware Hub.

The BIOS can be updated by following the instructions on page 55 in Chapter 3.

Serial ATA and IDE Auto Configuration

If you install a Serial ATA or IDE device (such as a hard drive) in your computer, the autoconfiguration utility in the BIOS automatically detects and configures the device for your computer. You do not need to run the BIOS Setup program after installing a Serial ATA or IDE device. You can override the auto-configuration options by specifying manual configuration in the BIOS Setup program.

PCI and PCI Express Auto Configuration

If you install a PCI/PCI Express add-in card in your computer, the PCI/PCI Express autoconfiguration utility in the BIOS automatically detects and configures the resources (IRQs, DMA channels, and I/O space) for that add-in card. You do not need to run the BIOS Setup program after you install a PCI/PCI Express add-in card.

Security Passwords

The BIOS includes security features that restrict whether the BIOS Setup program can be accessed and who can boot the computer. A supervisor password and a user password can be set for the BIOS Setup and for booting the computer, with the following restrictions:

- The supervisor password gives unrestricted access to view and change all Setup options. If only the supervisor password is set, pressing <Enter> at the password prompt of Setup gives the user restricted access to Setup.
- If both the supervisor and user passwords are set, you must enter either the supervisor password or the user password to access Setup. Setup options are then available for viewing and changing depending on whether the supervisor or user password was entered.
- Setting a user password restricts who can boot the computer. The password prompt is displayed before the computer is booted. If only the supervisor password is set, the computer boots without asking for a password. If both passwords are set, you can enter either password to boot the computer.

Chassis Intrusion

The board supports a chassis security feature that detects if the chassis cover has been removed. The security feature uses a mechanical switch on the chassis that can be connected to the chassis intrusion header on the desktop board. See Figure 20 on page 41 for the location of the chassis intrusion header.

Power Management Features

Power management is implemented at several levels, including:

- Advanced Configuration and Power Interface (ACPI)
- Hardware support:
 - Power connectors
 - Fan connectors
 - Suspend to RAM (Instantly Available PC technology)
 - Wake from USB
 - Wake from PS/2 keyboard/mouse
 - PME# wakeup support

ACPI

ACPI gives the operating system direct control over the power management and Plug and Play functions of a computer. The use of ACPI with the desktop board requires an operating system that provides full ACPI support.

Power Connectors

The desktop boards have three power connectors. See Figure 23 on page 46 for the location of the power connectors.

Fan Connectors

The desktop board has a 4-pin processor fan header and two 3-pin chassis fan headers. See Figure 22 on page 45 for the location of the fan headers.

Fan Speed Control (Intel[®] Precision Cooling Technology)

Intel Precision Cooling Technology automatically adjusts the processor fan speed based on the processor thermal diode temperature and adjusts the chassis fan speeds depending on the system temperature. System fan noise may be reduced by operating controlled chassis and processor fans at the minimum necessary speeds.

The processor and chassis fan speed control features can be disabled independently through the desktop board BIOS. Disabling the processor fan speed control will result in the fan operating at full speed if it is not a self controlled fan. It is recommended that processor fan speed control remain enabled (default BIOS setting) when using the processor fan heat-sink included with Intel[®] boxed processors. Disabling the chassis fan speed control results in chassis fans always operating at full speed. The chassis fan speed control feature should be disabled if a self-controlled chassis fan is attached to any controlled chassis fan header.

The overall system noise reduction will vary based on system configuration and environment.

Suspend to RAM (Instantly Available PC Technology)

CAUTIONS

For Instantly Available PC technology, the 5 V standby line for the power supply must be capable of delivering adequate +5 V standby current. Failure to provide adequate standby current when using this feature can damage the power supply and/or effect ACPI S3 sleep state functionality.

Power supplies used with this desktop board must be able to provide enough standby current to support the standard Instantly Available (ACPI S3 sleep state) configuration. If the standby current necessary to support multiple wake events from the PCI and/or USB buses exceeds power supply capacity, the desktop board may lose register settings stored in memory.

Instantly Available PC technology enables the board to enter the ACPI S3 (Suspend-to-RAM) sleep state. While in the S3 sleep state, the computer will appear to be off. When signaled by a wake-up device or event, the system quickly returns to its last known awake state.

The desktop board's standby power indicator, shown in Figure 3, is lit when there is standby power to the system. This includes the memory modules and PCI bus connectors, even when the computer appears to be off.

If the system has a dual-colored power LED on the front panel, the sleep state is indicated by the LED turning amber.

Wake from USB



Wake from USB requires the use of a USB peripheral that supports wake from USB.

USB bus activity wakes the computer from an ACPI S1 or S3 state.

Wake from PS/2 Keyboard/Mouse

PS/2 keyboard/mouse activity wakes the computer from an ACPI S1 or S3 state.

PME# Wakeup Support

When the PME# signal on the PCI bus is asserted, the computer wakes from an ACPI S1, S3, or S5 state.

Speaker

A speaker is mounted on the desktop board. The speaker provides audible error code (beep code) information during the Power-On Self-Test (POST).

Battery

A battery on the desktop board keeps the values in CMOS RAM and the clock current when the computer is turned off. Go to page 50 for instructions on how to replace the battery.

Real-Time Clock

The desktop board has a time-of-day clock and 100-year calendar. The battery on the desktop board keeps the clock current when the computer is turned off.

Before You Begin

\land CAUTIONS

The procedures in this chapter assume familiarity with the general terminology associated with personal computers and with the safety practices and regulatory compliance required for using and modifying electronic equipment.

Disconnect the computer from its power source and from any telecommunications links, networks, or modems before performing any of the procedures described in this chapter. Failure to disconnect power, telecommunications links, networks, or modems before you open the computer or perform any procedures can result in personal injury or equipment damage. Some circuitry on the board can continue to operate even though the front panel power button is off.

NOTE

Refer to Appendix B for regulatory requirements.

Follow these guidelines before you begin:

- Always follow the steps in each procedure in the correct order.
- Set up a log to record information about your computer, such as model, serial numbers, installed options, and configuration information.
- Electrostatic discharge (ESD) can damage components. Perform the procedures described in this chapter only at an ESD workstation using an antistatic wrist strap and a conductive foam pad. If such a station is not available, you can provide some ESD protection by wearing an antistatic wrist strap and attaching it to a metal part of the computer chassis.

Installation Precautions

When you install and test the Intel desktop board, observe all warnings and cautions in the installation instructions.

To avoid injury, be careful of:

- Sharp pins on connectors
- Sharp pins on printed circuit assemblies
- Rough edges and sharp corners on the chassis
- Hot components (like processors, voltage regulators, and heat sinks)
- Damage to wires that could cause a short circuit

Observe all warnings and cautions that instruct you to refer computer servicing to qualified technical personnel.

Installation Instructions



Follow these guidelines to meet safety and regulatory requirements when installing this board.

Read and adhere to all of these instructions and the instructions supplied with the chassis and associated modules. If the instructions for the chassis are inconsistent with these instructions or the instructions for associated modules, contact the supplier's technical support to find out how you can ensure that your computer meets safety and regulatory requirements. If you do not follow these instructions and the instructions provided by chassis and module suppliers, you increase safety risk and the possibility of noncompliance with regional laws and regulations.

Ensure Electromagnetic Compatibility (EMC) Compliance

Before computer integration, make sure that the power supply and other modules or peripherals, as applicable, have passed Class B EMC testing and are marked accordingly.

Pay close attention to the following when reading the installation instructions for the host chassis, power supply, and other modules:

Wiring and cables must also be UL listed or recognized and suitable for the intended use. The FCC Class B logo for home or office use signifies compliance with electromagnetic interference (EMI) requirements.

• In Canada

A nationally recognized certification mark such as CSA or cUL signifies compliance with safety requirements. The Industry Canada statement at the front of this product guide demonstrates compliance with Canadian EMC regulations.

Prevent Power Supply Overload

Do not overload the power supply output. To avoid overloading the power supply, make sure that the calculated total current loads of all the modules within the computer is less than the output current rating of each of the power supplies output circuits.

Place Battery Marking

AUTION

There is insufficient space on this desktop board to provide instructions for replacing and disposing of the Lithium ion coin cell battery. For system safety certification, the above statement or equivalent statement is required to be permanently and legibly marked on the chassis near the battery.

Installing the I/O Shield

The desktop board comes with an I/O shield. When installed in the chassis, the shield blocks radio frequency transmissions, protects internal components from dust and foreign objects, and promotes correct airflow within the chassis.

Install the I/O shield before installing the desktop board in the chassis. Place the shield inside the chassis as shown in Figure 4. Press the shield into place so that it fits tightly and securely. If the shield doesn't fit, obtain a properly-sized shield from the chassis supplier.

Installing and Removing the Desktop Board

\land CAUTION

Only qualified technical personnel should do this procedure. Disconnect the computer from its power source before performing the procedures described here. Failure to disconnect the power before you open the computer can result in personal injury or equipment damage.

Installing and Removing a Processor

Instructions on how to install the processor to the desktop board are given below.

Installing a Processor

Before installing or removing the processor, make sure the AC power has been removed by unplugging the power cord from the computer; the standby power LED should not be lit (see Figure 3 on page 22). Failure to do so could damage the processor and the board.

To install a processor, follow these instructions:

- 1. Observe the precautions in "Before You Begin" on page 25.
- 2. Open the socket lever by pushing the lever down and away from the socket (see Figure 6, A and B).

3. Lift the load plate. Do not touch the socket contacts (see Figure 7, C and D)

4. Remove the plastic protective socket cover from the load plate (see Figure 8, E). Do not discard the protective socket cover. Always replace the socket cover if the processor is removed from the socket.

5. Remove the processor from the protective processor cover. Hold the processor only at the edges, being careful not to touch the bottom of the processor (see Figure 9). Do not discard the protective processor cover. Always replace the processor back to the package if the processor is removed from the socket.

6. Hold the processor with your thumb and index fingers oriented as shown in Figure 10. Make sure fingers align to the socket cutouts (see Figure 10, F). Align notches (see Figure 10, G) with the socket see (Figure 10, H). Lower the processor straight down without tilting or sliding the processor in the socket.

To be fully compliant with all applicable Intel SDRAM memory specifications, the boards require DIMMs that support the Serial Presence Detect (SPD) data structure. You can access the PC Serial Presence Detect Specification at:

The desktop board has four 240-pin DDR2 DIMM sockets arranged as DIMM 0 (blue) and DIMM 1 (black) in both Channel A and Channel B.

Guidelines for Dual Channel Memory Configuration

Before installing DIMMs, read and follow these guidelines for dual channel configuration.

Two or Four DIMMs

Install a matched pair of DIMMs equal in speed and size in DIMM 0 (blue) of both channels A and B (see Figure 13).

All other memory configurations will result in single channel memory operation.

Installing DIMMs

To install a DIMM, follow these steps:

- 1. Observe the precautions in "Before You Begin" on page 25.
- 2. Turn off all peripheral devices connected to the computer. Turn off the computer and disconnect the AC power cord.
- 3. Remove the computer's cover and locate the DIMM sockets (see Figure 16).

- 4. Make sure the clips at either end of the DIMM socket(s) are pushed outward to the open position.
- 5. Holding the DIMM by the edges, remove it from its anti-static package.
- 6. Position the DIMM above the socket. Align the small notch at the bottom edge of the DIMM with the keys in the socket (see inset in Figure 16).
- 7. Insert the bottom edge of the DIMM into the socket.
- 8. When the DIMM is inserted, push down on the top edge of the DIMM until the retaining clips snap into place. Make sure the clips are firmly in place.
- 9. Replace the computer's cover and reconnect the AC power cord.

Removing DIMMs

To remove a DIMM, follow these steps:

- 1. Observe the precautions in "Before You Begin" on page 25.
- 2. Turn off all peripheral devices connected to the computer. Turn off the computer.
- 3. Remove the AC power cord from the computer.
- 4. Remove the computer's cover.
- 5. Gently spread the retaining clips at each end of the DIMM socket. The DIMM pops out of the socket.
- 6. Hold the DIMM by the edges, lift it away from the socket, and store it in an anti-static package.
- 7. Reinstall and reconnect any parts you removed or disconnected to reach the DIMM sockets.
- 8. Replace the computer's cover and reconnect the AC power cord.

Installing and Removing a PCI Express* x16 Card

When installing any PCI Express x16 card on the desktop board, ensure that it is fully seated in the PCI Express x16 connector before you power on the system. If the card is not fully seated in the PCI Express connector, an electrical short may result across the PCI Express connector pins. Depending on the over-current protection of the power supply, certain board components and/or traces may be damaged.

Installing a PCI Express x16 Card

- 1. Observe the precautions in "Before You Begin" on page 25.
- 2. Place the card in the PCI Express x16 connector and press down on the card until it is completely seated in the connector and the card retention notch snaps into place around the RM pin (Figure 17, A).
- 3. Secure the card's metal bracket to the chassis back panel with a screw (Figure 17, B).
- 4. Place the VGA cover over the back panel VGA port (Figure 17, C).





Removing the PCI Express x16 Card

Follow these instructions to remove the PCI Express x16 card from the RM:

- 1. Observe the precautions in "Before You Begin" on page 25.
- 2. Remove the screw that secures the card's metal bracket to the chassis back panel.
- 3. Push back on the RM lever until the retention pin completely clears the notch in the card.
- 4. Pull the card straight up.
- 5. Remove the VGA cover from the back panel VGA port.

Connecting the IDE Cable

The IDE cable can connect two drives to the desktop board. The cable supports the ATA-66/100 transfer protocol. Figure 18 shows the correct installation of the cable.

ATA-66/100 compatible cables are backward compatible with drives using slower IDE transfer protocols. If an ATA-66/100 disk drive and a disk drive using any other IDE transfer protocol are attached to the same cable, the maximum transfer rate between the drives may be reduced to that of the slowest drive.

Do not connect an ATA device as a slave on the same IDE cable as an ATAPI master device. For example, do not connect an ATA hard drive as a slave to an ATAPI CD-ROM drive.

For correct function of the cable:

- Observe the precautions in "Before You Begin" on page 25.
- Attach the cable end with the single connector (blue) to the Intel desktop board (Figure 18, A).
- Attach the cable end with the two closely spaced connectors (gray and black) to the drives (Figure 18, B).

Connecting a Serial ATA (SATA) Cable

The SATA cable (4-conductor) supports the Serial ATA protocol and connects a single drive to the desktop board. For correct cable function:

- 1. Observe the precaution in "Before You Begin" on page 25.
- 2. Attach the locking cable end to the connector on the board (Figure 19, A).
- 3. Attach the cable end without the lock to the drive (Figure 19, B).

Setting the BIOS Configuration Jumper Block

Always turn off the power and unplug the power cord from the computer before changing the jumper. Moving the jumper with the power on may result in unreliable computer operation.

Figure 25 shows the location of the desktop board's BIOS configuration jumper.

The three-pin BIOS jumper enables all board configurations to be done in BIOS Setup. Table 13 shows the jumper settings for the Setup program modes.

Clearing Passwords

This procedure assumes that the board is installed in the computer and the configuration jumper block is set to normal mode.

- 1. Observe the precautions in "Before You Begin" on page 25.
- 2. Turn off all peripheral devices connected to the computer. Turn off the computer. Disconnect the computer's power cord from the AC power source (wall outlet or power adapter).
- 3. Remove the computer cover.
- 4. Find the configuration jumper block (see Figure 25).
- 5. Place the jumper on pins 2-3 as shown below.



- 6. Replace the cover, plug in the computer, turn on the computer, and allow it to boot.
- 7. The computer starts the Setup program. Setup displays the Maintenance menu.
- 8. Use the arrow keys to select Clear Passwords. Press <Enter> and Setup displays a pop-up screen requesting that you confirm clearing the password. Select Yes and press <Enter>. Setup displays the maintenance menu again.
- 9. Press <F10> to save the current values and exit Setup.
- 10. Turn off the computer. Disconnect the computer's power cord from the AC power source.
- 11. Remove the computer cover.
- 12. To restore normal operation, place the jumper on pins 1-2 as shown below.



13. Replace the cover, plug in the computer, and turn on the computer.

Replacing the Battery

A coin-cell battery (CR2032) powers the real-time clock and CMOS memory. When the computer is not plugged into a wall socket, the battery has an estimated life of three years. When the computer is plugged in, the standby current from the power supply extends the life of the battery. The clock is accurate to \pm 13 minutes/year at 25 °C with 3.3 VSB applied.

When the voltage drops below a certain level, the BIOS Setup program settings stored in CMOS RAM (for example, the date and time) might not be accurate. Replace the battery with an equivalent one. Figure 26 on page 54 shows the location of the battery.

3 Updating the BIOS

The BIOS Setup program can be used to view and change the BIOS settings for the computer. The BIOS Setup program is accessed by pressing the $\langle F2 \rangle$ key after the Power-On Self-Test (POST) memory test begins and before the operating system boot begins.

This chapter tells you how to update the BIOS by either using the Intel Express BIOS Update utility or the Iflash Memory Update utility, and how to recover the BIOS if an update fails.

Updating the BIOS with the Intel[®] Express BIOS Update Utility

With the Intel Express BIOS Update utility you can update the system BIOS while in the Windows environment. The BIOS file is included in an automated update utility that combines the functionality of the Intel[®] Flash Memory Update Utility and the ease-of use of Windows-based installation wizards.

To update the BIOS with the Intel Express BIOS Update utility:

- Go to the Intel World Wide Web site: <u>http://support.intel.com/support/motherboards/desktop/</u>
- 2. Navigate to the D945GCZ page, click "[view] Latest BIOS updates," and select the Express BIOS Update utility file.
- 3. Download the file to your hard drive. (You can also save this file to a diskette. This is useful if you are updating the BIOS for multiple identical systems.)
- 4. Close all other applications. This step is required. Your system will be rebooted at the last Express BIOS Update window.
- 5. Double-click the executable file from the location on your hard drive where it was saved. This runs the update program.
- 6. Follow the instructions provided in the dialog boxes to complete the BIOS update.

Updating the BIOS with the Iflash Memory Update Utility

With the Iflash BIOS update utility you can update the system BIOS from a floppy disk or other bootable media. The utility available from the Web provides a simple method for creating a bootable flash memory update floppy that will automatically update your BIOS.

Obtaining the BIOS Update File

You can update to a new version of the BIOS by using the BIOS update file. The BIOS update file is a compressed self-extracting archive that contains all the files you need to update the BIOS. The BIOS update file contains:

- New BIOS files
- BIOS recovery files
- Intel Flash Memory Update Utility

You can obtain the BIOS update file through your computer supplier or by navigating to the Desktop Board D945GCZ page on the Intel World Wide Web site at:

http://support.intel.com/support/motherboards/desktop

Navigate to the D945GCZ page, click "[view] Latest BIOS updates," and select the Iflash BIOS Update utility file.

NOTE

Review the instructions distributed with the update utility before attempting a BIOS update.

The Iflash Memory Update utility allows you to:

- Update the BIOS in flash memory
- Update the language section of the BIOS

Updating the BIOS

L CAUTION

The AUTOEXEC.BAT file provided with the update files updates the BIOS. Do not interrupt the process or the system may not function.

- 1. Boot the computer with the BIOS update diskette in drive A. During system boot, the AUTOEXEC.BAT file provided with the update files will automatically run the BIOS update process.
- 2. When the update process is complete, the monitor will display a message telling you to remove the diskette and to reboot the system.
- 3. As the computer boots, check the BIOS identifier (version number) to make sure the update was successful. If a logo appears, press <Esc> to view the POST messages.

Recovering the BIOS

It is unlikely that anything will interrupt the BIOS update; however, if an interruption occurs, the BIOS could be damaged. The following steps explain how to recover the BIOS if an update fails. The following procedure uses recovery mode for the Setup program. See page 48 for more information on Setup modes.



NOTE

Because of the small amount of code available in the boot block area, there is no video support. You will not see anything on the screen during this procedure. Monitor the procedure by listening to the speaker and looking at the diskette drive LED.

- 1. Turn off the computer, disconnect the computer's power cord, and disconnect all external peripherals.
- 2. Remove the computer cover and locate the configuration jumper block (see Figure 25).
- 3. Remove the jumper from all pins as shown below to set recovery mode for Setup.



- 4. Insert the bootable BIOS update diskette into diskette drive A.
- 5. Replace the computer cover, connect the power cord, turn on the computer, and allow it to boot. The recovery process will take a few minutes.
- 6. Listen to the speaker:
 - Upon applying power, drive A will begin to show activity. In about a minute, two beeps are heard and drive A activity ceases (temporarily) indicating the successful recovery of the BIOS core. Drive A activity will begin again followed by two more beeps indicating the successful recovery of the boot block. This sequence of events indicates a successful BIOS recovery.
 - A series of continuous beeps indicates a failed BIOS recovery.
- 7. If recovery fails, return to step 1 and repeat the recovery process.
- 8. If recovery is successful, turn off the computer, and disconnect its power cord.
- 9. Remove the computer cover and continue with the following steps.
- 10. On the jumper block, reinstall the jumper back on pins 1-2 as shown below to set normal mode for Setup.



- 11. Leave the update diskette in drive A, replace the computer cover, and connect the computer's power cord.
- 12. Turn on the computer and continue with the BIOS update.

Configuring the BIOS for Intel Matrix Storage Technology

- 1. Assemble your system and attach two or more SATA hard drives.
- 2. Enter system BIOS Setup by pressing the <F2> key after the Power-On-Self-Test (POST) memory tests begin.
- 3. Go to Advanced \rightarrow Drive Configuration \rightarrow Configure SATA as; ensure RAID is selected.
- 4. Then save your settings by pressing $\langle F10 \rangle$.

Creating Your RAID Set

- 1. Upon re-boot, you will see the following Intel Matrix Storage Manager option ROM status message on the screen: Press <Ctrl-I> to enter the RAID Configuration Utility. Press <Ctrl-I> and enter the RAID Configuration Utility.
- 2. In the Intel Matrix Storage Manager option ROM Main Menu, select option #1: Create RAID Volume. Enter a volume name and press <Enter>.

NOTE: The RAID Volume name must be in English alphanumeric ASCII characters.

- Use the arrow keys to select RAID 0 or RAID 1 (if only two SATA drives are available), RAID 5 and RAID 10 (these options will only appear if three or four SATA drives are installed respectively). Press <Enter> once you have selected the RAID LEVEL.
- 4. Select the drives to be used in the RAID array (only if there are more than two drives available) and press <Enter>.
- 5. Select the strip size, if necessary, and press <Enter>.
- 6. Enter the size of the volume (if you select less than the maximum volume size, you can then create a second RAID array on the remaining portion of your volume) and press <Enter>.
- 7. Finally, press <Enter> to Create Volume.
- 8. Exit the Option ROM user interface by pressing <Esc> or going to the EXIT option in the MAIN MENU.

Loading the Intel Matrix Storage Technology RAID Drivers and Software

- 1. Begin Windows Setup by booting from the Windows installation CD.
- At the beginning of Windows Setup, press <F6> to install a third-party SCSI or RAID driver. When prompted, insert the floppy disk labeled RAID Driver. Install the Intel 82801GR SATA RAID Controller driver.
- 3. Finish the Windows installation and install all necessary drivers.
- 4. Install the Intel Matrix Storage Console software via the Intel Express Installer CD included with your desktop board or after downloading it from the Internet at http://support.intel.com/support/motherboards/desktop/. The Intel Matrix Storage Console software can be used to manage the RAID configuration.

Setting Up a "RAID Ready" System

The Intel Matrix Storage Technology Console software offers the flexibility to upgrade from a single Serial ATA drive to RAID without reinstalling the operating system, when a second SATA hard drive is added to the system.

Follow the steps described in the headings from this section: "Configuring the BIOS for Intel Matrix Storage Technology" and "Loading the Intel Matrix Storage Technology RAID Drivers and Software".

Once you have added additional SATA drives, open the Intel Matrix Storage Technology Console Software and follow the directions to update to a RAID setup.

A Error Messages and Indicators

Desktop board D945GCZ reports POST errors in two ways:

- By sounding a beep code
- By displaying an error message on the monitor

BIOS Beep Codes

The BIOS also issues a beep code (one long tone followed by two short tones) during POST if the video configuration fails (a faulty video card or no card installed) or if an external ROM module does not properly checksum to zero. Table 14 lists the BIOS codes.

When a recoverable error occurs during the POST, the BIOS displays an error message describing the problem. Table 15 gives an explanation of the BIOS error messages.

MULTI_BIT_ECC_ERROR	The firmware has detected that a Multi-Bit ECC Error occurred.
SINGLE_BIT_ECC_ERROR	The firmware has detected that a Single-Bit ECC Error occurred.
CMOS_BATTERY_ERROR	The firmware has detected that a CMOS battery failure occurred.
CMOS_CHECKSUM_ERROR	The firmware has detected that a CMOS Checksum Error occurred.
CMOS_TIMER_ERROR	The firmware has detected that the system date/time has not been set.
MEMORY_SIZE_DECREASE_ERROR	The firmware has detected that the system memory has decreased.
INTRUDER_DETECTION_ERROR	The system chassis was opened.
SPD_TOLER_ERROR	SERIAL PRESENCE DETECT (SPD) device data missing or inconclusive. Properly programmed SPD device data is required for reliable operation. DDR2 533 MHz memory assumed at slowest timings.
MEM_OPTIMAL_ERROR	The installed amount of memory in Channel A is not equal to the amount of memory in Channel B. Maximum memory performance is achieved with equal amounts of memory installed in each channel.
